A lengthy and detailed discussion took place of the various publicity programs now being used to promote the plebiscite.

It was agreed that a mass public meeting should be held in support of the college on Thursday, February 29th, in West Vancouver Senior Secondary School (this date was subsequently changed to Wednesday, February 28th). Various speakers were suggested, including Dr. Ian McTaggart-Cowan, Dr. Bart Wales, Mr. Stewart McGill, Mr. Dean Gourd, Mr. Frank Beinder, Dr. Archie McKinnon, and others. Selection of speakers was left to Mr. Peter Jones. The physical arrangements were left to Mr. Ferguson and the West Vancouver School Board.

It was further agreed that with regard to publicity material, Mr. Parkes would supply the various Board Offices with the material, and local committees would arrange for the local distribution.

The Committee approved the plan of an open letter to Secondary students, providing them with specific details about the proposed college. Mr. Lucas was asked to prepare this letter.

The Committee then entered into a long discussion of the matter of projected costs for the college, which Mr. Jones had promised the Committee would produce. Data from the Davis, MacConnell, Ralston report was examined and evaluated, and new projections of future costs developed.

It was decided to produce estimated costs for 1968, 1969, and 1973, assuming that permanent buildings are built at that time.

The proposed announcement for administrative staff was approved and referred to Williams & Wilson for professional assistance. The effective date was advanced to April 30th from March 15th. The summary of the Davis, MacConnell, Ralston report prepared by Mr. Ferguson was distributed to members of the Committee. The thanks of the Committee were extended to Mr. Ferguson.

The Secretary was asked to write a letter to the Deputy Minister asking for the Department's participation in the cost of the initial library.

Board members were reminded that they are expected to submit names of proposed nominees to the Regional College Council at the meeting of February 24th.

The next meeting was set for Saturday, February 24th at 9:00 a.m. in the Administrative Offices of the North Vancouver School Board.
