WHEREAS Capilano College has been granting degrees for over fifteen (15) years; and

WHEREAS there are presently over one thousand (1000) degree graduates from Capilano whose future prospects depend upon the continued existence of Capilano as a recognized degree granting institution; and

WHEREAS there are currently hundreds of students enrolled in programs which could lead to Capilano degrees and whose future may now be uncertain; and

WHEREAS Capilano is developing new degrees in areas such as Early Childhood Care and Education, Performing Arts, Working with Autistic Children, Film Production; and

WHEREAS Capilano has responsibility for a wide geographical area extending from Deep Cove to Egmont on the Sunshine Coast, to Pemberton, Mt. Currie, Squamish and Whistler; and

WHEREAS Capilano has been asked to offer its degrees in China and has agreements to bring many international students to study in its degree programs in Canada; and

WHEREAS Capilano's international programs inject about \$20 million into the local economy; and

WHEREAS Capilano has long standing campuses on the Sunshine Coast and in Squamish; and

WHEREAS there is no other Regional University in the North Shore-Howe Sound-Sunshine Coast corridor; and

WHEREAS the educational goals and activities of Capilano are indistinguishable from those proposed Regional Universities;

THEREFORE, be it RESOLVED, that if, after consideration of the Campus 2020 report, the government creates Regional Universities, the Board of Capilano College requests the Minister of Advanced Education to designate Capilano College a Regional University.
